

In 1999 she assumed responsibility for Statoil's West Africa exploration efforts. From April 2000 to March 2001, she was Texaco's vice president of core worldwide exploration. Ms. Cunningham joined Noble Energy as a senior vice president in April 2001 where she is responsible for exploration worldwide.

Ms. Cunningham has been active in industry and the community. In 2005 she was elected to the board of Cliffs Natural Resources, an iron ore and metallurgical coal mining company. She has also served on the boards of the Houston Area Women's Center and the Houston Geological Society. During 2010 and 2011 she served as chairman of the Offshore Technology Conferences (OTC), representing the American Association of Petroleum Geologists (AAPG). And in 2011 Susan was selected to serve on the AAPG Advisory Board.
